## Privacy Policy

#### <Collection of Personal Information>

## <Management of personal information>

#### (Provision of Personal Information to Third Parties)

The Executive Committee and the Secretariat may outsource the handling of all or part of the acquired personal information within the scope necessary to achieve the purpose of use. In such cases, the Executive Committee and the Secretariat will select a subcontractor that is deemed to handle personal information appropriately, and will make necessary arrangements in contracts and other agreements to prevent leakage of customers' personal information through appropriate management of personal information and maintenance of confidentiality, and will have the subcontractor implement appropriate management.

The Executive Committee confirms that you have the right to request disclosure, correction, deletion, or cessation of use of your personal information, and if you wish to take these actions, we will respond promptly and in good faith after confirming your identity.

### ⟨Storage period of personal information⟩

The Executive Committee will securely delete personal information after an appropriate period of time has elapsed once the purpose for which the information is used has been achieved. However, information required to be retained by law will be retained in accordance with such law.
